Good evening, friends. Welcome to the 2019 NAEMT General Membership Meeting! It's an honor to share this evening with you and I thank you all for being here. Each of you have made a special effort to attend this meeting, and many of you have traveled long distances to join us. I thank each and every one of you for your support of NAEMT.

Tonight, we come together to recognize what we have achieved this year and appreciate what our association and its more than 160 volunteer members, is doing to advance the EMS profession. We will celebrate our accomplishments and thank the many members who contribute to our success. And, we will recognize members of our profession who have demonstrated outstanding achievement.

Bryan was a true friend of NAEMT, the EMS profession and all EMS practitioners. We extend our heartfelt condolences to his family.

Joining me in our goal to advance the EMS profession are my fellow members of the NAEMT Board of Directors. This incredible group of leaders dedicate their time and expertise to the ongoing work of our association. I am truly blessed to work with them.

While NAEMT is a forward-focused association, we never forget how we have grown over the years and the leaders who led us through the challenges along the way. We are very grateful for the leadership provided to NAEMT by our Past Presidents. If any of our Past Presidents or Board members are here tonight, please stand and be recognized.

Thank you, very much for your service and for being here tonight.

As President, I have worked with our Board and other committed members to actively respond to the issues and challenges that impact our profession. Many times, these efforts have been in partnership with other national EMS organizations. Working together, we have made significant strides... and will continue to do so

In accordance with our bylaws, I am proud to provide the highlights of our association's achievements this year.

Advocacy is one of the most valuable activities NAEMT undertakes on behalf of our members and profession. This year, we've advocated for laws and regulations that support EMS practitioners and improve the care we provide to our patients. Our legislative priorities included:

- Funding for the Supporting and Improving Rural EMS Needs Law, more commonly known as the SIREN Act. Last year, the SIREN Act passed both Houses of Congress as part of the Agriculture Improvement Act of 2018 and was signed into law. When funded, this law will create a grant program for public and non-profit EMS agencies in rural areas, many of which are at the forefront of the opioid epidemic—to support the recruitment, retention, education, and equipment for EMS personnel in rural areas.
- Passage of the Workplace Violence Prevention for Health Care and Social Service Workers Act, to mandate the federal Occupational Safety and Health Administration (OSHA) to create a national standard requiring that healthcare and social service employers develop and implement a comprehensive workplace violence

prevention plan. A big thank you to the nearly 2,000 members who sent emails to their Representatives and Senators. This bill now has 222 cosponsors in the House and 24 in the Senate.

Two bills that NAEMT actively supported were passed this year and signed into law:

- The Volunteer Responder Incentive Protection Act to bolster volunteer EMS and fire recruitment and retention by allowing volunteers to receive nominal incentives—property tax deductions and up to \$600 per year of other types of benefits—without having to pay tax on them.
- The Pandemic and All-Hazards Preparedness and Advancing Innovation Act (PAHPA), to strengthen our nation's existing preparedness and response programs. The bill included two NAEMT legislative priorities—the Mission Zero Act to support military-civilian partnerships that strengthen our nation's trauma response capacity and the Good Samaritan Act to protect bystanders, including EMS practitioners, who come to the aid of victims during a disaster.

In addition to these bills, our Advocacy Committee reviewed and made recommendations on 28 pieces of federal legislation to ensure that NAEMT has a position on every federal bill that impacts our practitioners and patients. Members can view all of these bills on NAEMT's Online Legislative Service, and can use this service to find your congressional leaders, see how they vote, and send emails to them to voice your opinion on these bills.

We worked very hard this year to ensure that the EMS profession was represented on key issues that impact every aspect of what we do.

- In January, NAEMT published a position supporting enhanced education requirements for the EMS workforce that support the evolving role of EMS.
- In April, we submitted comment to the HHS National Coordinator for Health Information Technology outlining how improved integration of EMS with Healthcare Information Technology can positively impact patient outcomes.
- In May, we submitted a joint comment to Congress with several other organizations on the issue of balance or "surprise" billing, to educate congressional leaders on this issue relative to ground ambulance service.
- In July, the NAEMT Board approved a new position statement prepared by our EMS Workforce Committee calling for the federal government to accurately and fully count the EMS workforce, including all firefighter-EMTs, firefighter-paramedics, and volunteer EMS practitioners.
- In August, we sent a letter drafted by our EMS Preparedness Committee to the HHS Assistant Secretary for Preparedness and Response citing the absence of EMS as a stakeholder and source of expertise in the development of the 2019-2022 National Health Security Strategy.
- In August and again in September, NAEMT commented on the NHTSA-sponsored project to revise the National EMS Education Standards. We expressed concern with the lack of EMS stakeholder involvement in the drafting of the revisions, among other issues.
- Last month, we provided our comments to CMS on their proposed rule governing the process they will use to collect cost, revenue, utilization, and other information on ground ambulance service and on their proposed data collection instrument.
- And, we continued to speak out on one of the most important issues for our members pay and benefits, calling for equitable compensation for the EMS workforce and equitable reimbursement for the patient care we provide.

NAEMT hosted the 10th annual EMS On The Hill Day on April 10th. It was another incredible event with 250 EMS professionals - practitioners, physicians, educators, and fire chiefs - representing EMS agencies from all delivery models from 40 states, D.C. and Puerto Rico, attending meetings with 200 congressional leaders and their staff at which key EMS issues were discussed.

Please mark your calendars for March 24-25, 2020 for next year's EMS On The Hill. This event is a critical part of our advocacy effort and you are all invited and encouraged to attend.

Election season is coming. Primaries will begin in early 2020. Now more than ever, we must have strong visibility with national and state elected officials to ensure that they understand what EMS needs to deliver quality patient care. One way to strengthen our presence with elected leaders is by contributing to their election or reelection campaigns through NAEMT'S EMS PAC. We established the PAC last year and we thank those members who have made contributions. All contributions of all sizes are welcomed. For more information on how to contribute, please visit the NAEMT Booth on the EMS World Exhibit floor, #1029. Our NAEMT EMS PAC Steering Committee is also available to answer any and all questions about our PAC.

In May, NAEMT partnered with ACEP to promote National EMS Week. Focusing on this year's theme, *Beyond the Call*, NAEMT highlighted on social media the hundreds of EMS Week celebrations, recognitions, media reports, and gestures of appreciation for EMS practitioners and agencies around the country. Thank you to the many members who submitted stories and photos. We were honored to highlight your work.

Early in the year, we conducted a survey of our members to understand what their agencies were doing to prevent and respond to acts of violence against their personnel. The results of this survey have just been published in the NAEMT National Report on EMS Violence. This report provides a very clear picture of this ongoing challenge and provides recommended actions that EMS agencies can take to protect and support practitioners. I want to recognize the members of our EMS Workforce Committee for their contributions to this tremendous work. Congratulations team! Great job. This report will be distributed to all NAEMT members, national and state EMS organizations, federal agencies, and congressional offices.

This same team was also responsible for producing the 2019 Guide to Building an Effective EMS Wellness and Resilience Program designed to assist EMS agencies in developing programs that aid their EMS personnel in maintaining their physical, mental and emotional well-being. This guide is free and can be downloaded from the Publications tab on NAEMT's web site.

Our EMS 3.0 Committee also produced a survey that was sent to EMS managers and MIH-CP program contacts asking them what non-traditional EMS services their agencies are currently offering. The results of this survey will provide our industry with a snapshot of what types of non-traditional EMS services are being offered, how they are being delivered, and how agencies are receiving payment for these services. We will present these findings as an infographic in the near future.

Turning to education... and folks... these <u>are just</u> the highlights, NAEMT published new education curricula, conducted webinars and hosted workshops to strengthen the knowledge and skills of EMS practitioners, and provided EMS agencies with resources to improve their operations and support their personnel.

- In January, the 9th edition PHTLS course materials published in English. In March, NAEMT held its first ever PHTLS Instructor Update in another language and another country, when Dr. Alex Eastman, Aaron Miranda and Kim Mace presented the Update in Spanish in Quito, Ecuador. In June, the 9th edition published in Spanish. A big thanks goes out to the multinational Spanish Editorial Committee led by Dr. Alejandro Gomez that our publishers Jones and Bartlett Learning used to ensure that our Spanish translation was produced accurately and on time. PHTLS is being translated or localized in 15 additional editions, and we have many dedicated faculty around the globe involved in this effort.
- In March, NAEMT collaborated with NAEMSP and IAFC to conduct a free webinar on the new Emergency Triage, Treat and Transport (ET3) Model created by the CMS Center for Medicare and Medicaid Innovation (CMMI). The webinar, sponsored by ESO Solutions and FirstWatch, provided the clinical, operational, and financial details for EMS agencies to consider before submitting an application to participate in the ET3 model.
- In April, NAEMT hosted two EMS 3.0 workshops in conjunction with EMS On The Hill Day—one workshop focused on building relationships with payers, and the other presented an overview of the skills and knowledge needed to become a community paramedic. All workshop participants attended the keynote

luncheon speech presented by Dr. Dawn Alley, Director of the Prevention and Population Health Group at CMMI and the ET3 Project Lead.

- Also in April, NAEMT hosted a free *Get Ahead of Stroke* webinar in collaboration with the Society of NeuroInterventional Surgery to help prepare EMS practitioners to respond to stroke patients. The webinar was supported by an educational grant from Medtronic.
- In June, the 2nd edition of NAEMT's Tactical Emergency Casualty Care (TECC) 16-hour course published in English. This course is also being translated into multiple languages for its global audience. And, in August, we held a beta-test of the 8-hour version of this course designed for law enforcement officers and other first responders. Responses from this beta will ensure that our content is appropriate and relevant to this key sector of the first response community. The TECC-LEO curriculum will be published in English by the end of the year.
- In August, NAEMT and the Academy of International Mobile Healthcare Integration (AIMHI) partnered to launch a new series of free one-hour webinars with CE credit on EMS finance. These webinars are designed to explain the economics of EMS, including
 - the sources of funding
 - \circ $\$ how EMS system design and payer mix impact agency finances
 - the cost drivers of EMS service delivery
 - what Medicare, Medicaid and commercial insurers reimburse for EMS care
 - the anatomy of an ambulance response from 911 to reimbursement
 - how documentation impacts EMS reimbursements and
 - the impact of "in or out" of network on EMS reimbursement

The first two webinars have been very well attended, and the third webinar is scheduled for October 30. NAEMT thanks our corporate partner Zoll for sponsoring this webinar series. If you missed these webinars, they will be offered for CE on the online Recert education platform.

- Yesterday, NAEMT's Advanced Medical Life Support (AMLS) 3rd edition Instructor Update was conducted. Please join me in extending a very special thank you to the AMLS Committee for your efforts to make this update possible. And... our deep appreciation to the many chapter authors and editors, and lesson and patient simulation authors who are contributing to this third edition of a tremendous course. The 3rd edition textbook will publish by the end of the month in English, and the course materials will be finalized by the end of the year.
- And, over the last two days, NAEMT conducted a beta test of a new Critical Care Test Prep course to help paramedics successfully take the Flight Paramedic and Critical Care Paramedic certification and recertification exams offered by IBSC. Thank you to our course authors Keith Widmeier, Leslie Hernandez, Rick Slaven, Christie Rippel, Trent Dobbs, and Dr. Amjad Musleh.
- Today, over 300 EMS practitioners, emergency physicians, trauma surgeons, emergency nurses and trauma coordinators attended the ^{8th} annual World Trauma Symposium. Thank you, Dr. Eastman for bringing together a superlative group of global trauma experts to share their insights. The Symposium truly is the best prehospital trauma conference in the world and the attendees enjoyed and benefited from such a great program. During the Symposium, three awards were presented to very worthy trauma leaders:
 - Retired Colonel, Trauma Surgeon, and U.S. House Representative from Ohio Brad Wenstrup received the 2019 Scott Frame Lecture Award. Representative Wenstrup saved his fellow congressman Steve Scalise from Louisiana during the tragic congressional baseball shooting a couple of years ago.
 - NAEMT Affiliate Faculty and Education Committee Member Dave Page received the 2019 Scott Frame Service Award for his globe-trotting efforts throughout Latin America and other parts of the world to bring NAEMT education to all prehospital providers that desire quality education.

 And NAEMT's Tactical Medical Director and Liaison to the Committee on TCCC, Dr. Warren Dorlac received the 2019 Norman McSwain Leadership Award for his outstanding leadership as a U.S. military trauma surgeon.

Please join me in recognizing and thanking these three outstanding individuals for sharing their tremendous expertise for the betterment of trauma patients.

And, to help our members, without whom none of these great achievements would be possible...

- NAEMT awarded \$25,000 in scholarships so far this year to NAEMT members to help advance their EMS careers. Through NAEMT's partnership with Columbia Southern University scholarship, another \$13,500 will be awarded by the end of the year. In addition, the NAEMT Foundation awarded \$3,000 in scholarships to individuals interested in pursuing a career in EMS.
- NAEMT has added many new member benefits this year -
 - 25% discounts on two online courses First Responder Support & Resilience and Rescue D: Meeting the Needs of Patients with Disabilities from JBL's Public Safety Group. Both courses provide engaging simulations to prepare you for whatever strikes!
 - Through our partnership with Savvik,

 - up to 55% savings on FedEX shipping costs;
 - o 20% discount on access to telemedicine through Live MD for members and their families; and
 - discounts at Staples.
 - And, this is in addition to the existing package of over 30 benefits that are included as part of your membership, including

And, I am proud to say that NAEMT continues to be the most transparent EMS organization in the country.

- We publish our membership numbers,
- We make the minutes of our Board meetings available for members right from our web site.
- We publish our audited financial statements each year in the NAEMT annual report.
- We have open elections in which all active members of the association can vote for members of the Board. In fact, the election period opened today and will remain open through October 28th. So, members, please exercise your right and vote online for the NAEMT directors of your choice.

 And...we maintain social media platforms to allow our members to express their opinions on EMS issue and their opinions about NAEMT, even when those opinions are not positive. The only restrictions we place on our members using these platforms is that profanity or harassment is not tolerated. As the organization representing the EMS profession, we must ensure that NAEMT maintains professional standards.

We take all of these actions because we understand that NAEMT is an organization of <u>members</u>. It's your organization, and we - the NAEMT Board, the committees and coordinators we appoint and the staff we employ - are stewards of your organization. You elect your Board members and entrust them with your organization and its resources. We carry out our responsibilities with the respect and integrity that our members deserve. Your elected leaders and your staff are deeply honored to serve you.

Serving the US Navy for the past seven years, Petty Officer Russell has deployed with 3rd Reconnaissance Battalion in Okinawa, Japan as well as serving two overseas tours to Africa with Marine Special Operations Teams. It is an honor to present the 2019 ZOLL Volunteer EMS Service award to **Princess Anne Courthouse Volunteer Rescue Squad** from Virginia Beach. Will the members of the **Princess Anne Courthouse Volunteer Rescue Squad** – this year's Volunteer EMS Service of the Year – please come to the stage.

This agency has served the emergency medical needs of the Princess Anne/General Booth/Redmill/Salem areas of the City of Virginia Beach since 1947. Its 110 operational and administrative members serve approximately 50,000 hours per year and answers approximately 5,000 calls annually. Committed to professional development, the agency's leadership nominates members for recognition through local, regional, and national programs as well as outside community organizations. Princess Anne Courthouse provides coordination, scheduling and staffing for large-scale events, as well as community education and employee training. Regularly scheduled "Squad Days" promote comradery. On May 31 of this year, Princess Anne's units were the first on the scene of the Virginia Beach Active Shooter incident. On June 2, members walked from the agency's home station to the memorial site to pay respects before gathering at a local eatery for dinner. "We work and respond to calls together, so it is only right we break bread together," said Trevor Kirk, chair of the board of directors. "We join the rest of the city in

making sure Virginia Beach will not be remembered as a place of violence, but as a place of unwavering support and love for our community."

It is our pleasure to present the 2019 Dick Ferneau Career EMS Service award to the **San Antonio Fire Department EMS** of Texas. Will the members of the **San Antonio Fire Department EMS** – this year's Career Service of the Year – please come to the stage.

San Antonio EMS serves the city and surrounding regions with a 400-person staff, 43 ambulances and an EMS budget of \$68 million, responding to 160,000 calls per year. The agency is innovative, progressive and fearless when it comes to protecting the health and safety of citizens and prehospital responders. In October 2018, San Antonio EMS began to offer patients whole blood as a treatment for hemorrhagic shock. The agency has deployed behavioral health and MIH programs that are a first of their kind in the nation. As a response to threats of MCIs, terror attacks and active shooter incidents, San Antonio EMS and UT Health Department of Emergency Health Sciences, Office of the Medical Director collaborated to form the Medical Special Operations Unit, a specialized team of paramedics trained to provide the highest level of medical care and ensure the health of uniformed personnel. The agency strives to improve out-of-hospital cardiac arrest survival and has created a medical screening tool for behavioral health patients, a wildland firefighter force protection team, a prehospital infant safe sleep initiative, an acute care station in the largest homeless shelter in Texas, a sepsis triage protocol, LVO stroke identification tool, and clinical operating guidelines apps.

Our final award... the Rocco V. Morando Lifetime Achievement Award... is NAEMT's most prestigious recognition of an individual's contribution to prehospital emergency medical care and the EMS profession. The award is granted to select individuals who, through their actions, leadership and spirit, have demonstrated a lifetime commitment and dedication to the advancement of EMS. THE 2019 ROCCO V. MORANDO LIFETIME ACHIEVEMENT AWARD RECIPIENT IS DR. DAVID E. PERSSE.

Dr. Persse's career in medicine started with 10 years of experience as a field paramedic and paramedic instructor in upstate New York and New Jersey. After receiving his pre-med training at Columbia University in New York City, he attended Georgetown University School of Medicine in Washington, D.C. Dr. Persse completed residency training in emergency medicine at Harbor-UCLA Medical Center in Torrance, California. He completed fellowship training in emergency medical services at the Baylor College of Medicine in Houston and the City of Houston Emergency Medical Services program. He also completed his fellowship resuscitation research at the Ohio State University.

Following his EMS fellowship, Dr. Persse became the assistant medical director for the emergency medical services system of Houston. He then moved to California to become the medical director of the Los Angeles County Paramedic Training Institute, and the assistant medical director of the Los Angeles County EMS Agency. In 1996, Dr. Persse assumed the role of the Director of Emergency Medical Services for the City of Houston. In May 2004, he was appointed by the City Council as Houston's Public Health Authority.

He has been the lead author or co-author on over 40 peer-reviewed journal articles. He has overseen Houston's Public Health response to Hurricanes Katrina, Rita, Ike, and Harvey, as well as the H1N1 influenza pandemic, and he is currently the incident commander for the Zika virus response.

Dr. Persse is a member of the board of directors and executive committee for the South East Texas Trauma Regional Advisory Council and is past chair of the National Registry of Emergency Medical Technicians. He is a 2015 EMS Top 10 Innovator Award Winner from the Journal of Emergency Medical Services. He has been recognized by ACEP, NAEMSP, and other national organizations for his leadership in EMS.

Dr. Persse is a Professor of Emergency Medicine at Baylor and associate professor of emergency medicine at the University of Texas McGovern Medical School. He is also a tactical physician with the Houston police S.W.A.T. team as well as adjunct faculty for EMS Fellowship at UT McGovern Medical School.

His leadership and selfless giving of his time, talent and expertise has advanced EMS as a profession and improved patient care.
